## **GUARANTEE OF WARRANTY**

In fulfilling our commitment to you, the original Purchaser, Greysun Equipment Company, LLC provides the following as our Guarantee of Warranty for the equipment and / or services provided. Companies using the Equipment/Services noted who purchase through another dealer, agent, contractor, engineering firm or other non-user third party, or parties, would be considered the Original Purchaser under the terms of this Guarantee of Warranty. The User Company and plant location must be identified at the time of the order to be eligible for the Guarantee of Warranty.

This warranty applies to the following equipment.

Reconditioned Centrifuge:

Reconditioned and new equipment purchased from Greysun Equipment Company by the Original Purchaser is guaranteed to operate correctly from a mechanical aspect and to be free from any defects in parts, materials or workmanship for a period of time of six (6) months from shipment. A one (1) year warranty is guaranteed on any defects in parts, materials or workmanship for new drive motors or new controls from shipment. This Guarantee is dependent on an authorized Greysun Equipment Company Service Technician inspecting the installation in the Original Purchaser's plant and being present at the first start-up. Greysun Equipment Company does not offer any Process Guarantee unless specifically noted. As-is equipment purchased from Greysun Equipment Company has no Guarantee unless specifically noted.

Greysun Equipment Company is not responsible for and cannot offer a Guarantee of Warranty for damages to the equipment resulting from the following: A. Acts of God, fire, flood, theft, vandalism, accidents, labor difficulties, and/or civil encounters and the like. B. Use for which the equipment was not intended, abuse, misuse, improper lubrication, improper operation, improper assembly (by plant personnel), improper handling or extended storage by Original Purchaser or other party. C. Corrosion, erosion and ordinary wear and tear.

Any form of parts or accessories, equipment or modifications supplied by or installed by other dealers, repair shops, manufacturers, the owner, or any other third party, without the written consent and approval of Greysun Equipment Company shall be void from the Greysun Equipment Company Guarantee of Warranty. Parts and accessories provided by other parties or vendors to the owner for Greysun Equipment Company supplied equipment are covered by their Warranty only. Damage to equipment covered by the Greysun Equipment Company Guarantee of Warranty resulting from use of

unauthorized parts or the Greysun Equipment Company Guarantee of Warranty will not cover actions described in this paragraph.

Greysun Equipment Company shall not be responsible for any direct or indirect damages that are incurred during shipment of the subject equipment by any carrier whether by truck, rail, air, shipboard or other means.

Greysun Equipment Company shall not be responsible for any loss of product or downtime or other incidental losses as a result of failure of any equipment or services supplied by us. The liability of Greysun Equipment Company under this Guarantee of Warranty is limited to, at most, a full refund of the money paid by the Purchaser for the equipment and/or services noted above covered by this Guarantee of Warranty. All shipping, installation and removal costs are the responsibility of the Purchaser. All legal costs are the responsibility of the Purchaser.

Greysun Equipment Company shall not be responsible for material, repairs, parts, modifications or labor costs for work on the equipment unless the Original Purchaser has contacted Greysun Equipment Company and received written authorization by a Greysun Equipment Company agent. Unauthorized work, parts or actions per this paragraph will make void the Guarantee of Warranty.

Greysun Equipment Company shall not be bound by any term or condition contained in Purchaser's Purchase Order not consistent with these terms and conditions.
